As per approval of chairman, AMCEMT dt. 04/07/2020. You are appointed as **Casualty Medical Officer CUM Asst. Resi. Medical Officer (CMO CUM ARMO)** on contractual basis for 11 months having fixed monthly remuneration of Rs. 65,000/- (Statutory Deduction will be applicable) on following terms & conditions.

1. You are appointed for a period of 11 months starting from 08/07/2020.
2. Your appointment is purely on contract basis.
3. You will receive Rs. 65,000/- as fixed monthly remuneration. (Statutory Deductions like TDS and other will be applicable as per rules)
4. You have to carry out functions of Casualty Medical Officer as well as Asst. Resident Medical Officer as decided by the institute time to time.
5. During the course of your tenure at AMC MET or at any time thereafter, you will not disclose to any person, organization or institute, any information - confidential or otherwise, concerning the affairs of this institute.
6. You have to attend the hospital by putting on your own apron with nameplate / Identity Card affixed on it.
7. You will be debarred from any type of private practice including insurance work.
8. You will be required to work strictly in accordance with the instructions of your superior authority. You are expected to co-operate with other employees of the institution so as to achieve all round co-ordinate and efficient performance and making an effective contribution in the development of the institution of excellence.
9. Your service will be transferable to other hospital and medical facilities of AMC / AMC MET.
10. You will not have any type of lien on the scheduled post of Ahmedabad Municipal Corporation/AMC Medical Education Trust and does not hold any right against Ahmedabad Municipal Corporation.

11. The contract can be terminated with one month notice from either side.
12. In case of any complain related to irresponsible behavior of you, the contract will be terminated with immediate effect. The decision of AMC Medical Education Trust regarding continuation/reappointment will be final and you will not be entitled to claim any right for such continuation/retention/reappointment.
13. If you desire to resign prematurely during the service tenure, you may do so by giving one month's notice or salary in lieu thereof.
14. In case of no intimation to the effect that your services are continued, your service will automatically stand terminated on completion of the tenure of service of 11 month.
15. During the period of your service, you will be entitled for 11 days Casual Leave (a maximum of 11 days leave within a span of 11 month from the date of employment and not more than 3 days of leave at a onetime) and 11 days sick leave proportionate to service rendered by you.
16. Women employees can avail maternity leave WITHOUT PAY up to 60 days. Such leave could be availed before and/or after delivery of her child.
17. In case, you remain absent unauthorized period of more than 5 days continuously, your contract will automatically get terminated without any intimation. You will not be entitled for any re-appointment (shall become ineligible for further extension) in case his/her services are so terminated.
18. You have to enter in legal contract paper with the Medical Superintendent of Respective Hospital.
19. Your service will be subject to rules and regulations of this institution that are in force and that may be made from time to time.
