As per approval of chairman, AMC MET dt. 23/02/2022, You are appointed as Casualty Medical officer CUM Assistant Resident Medical Officer (CMO CUM ARMO) on contract basis for 11 months having fixed monthly remuneration of Rs. 65,000/- (statutory Deduction will be applicable) on following terms & condition.

- 1) You are appointed for a period of 11 months starting from 09/02/2022.
- 2) You are appointed is purely on contract basis.
- 3) You will receive the Rs. 65,000/- as fixed monthly remuneration (statutory Deduction like TDS and other will be applicable).
- 4) You have to carry out functions of Casualty Medical Officer as well as Assistant Resident Medical Officer as decided by the institute time to time.
- 5) You have to attend the hospital by putting on your apron with name plate/Id card affixed on it.
- 6) During the course of your employment in the college/hospital or any time thereafter, you will not disclose to any person, organization or institution, any information confidential or otherwise concerning the affairs of this institution.
- 7) You will be debarred from any type of private practice including insurance work.
- 8) You will be required to work strictly in accordance with the instruction of your superior authority. You are expected to co-operate with other employees of the institution so as to achieve all round co-ordinate and efficient performance and making an effective contribution in the development of the institution of excellence.
- 9) Your service will be transferrable to other hospital and medical facilities of AMC or AMC MET.
- 10) You will not have any type of lien on the schedule post of Ahmedabad Municipal Corporation/ AMC Medical Education Trust and does not hold any right against Ahmedabad Municipal Corporation.
- 11) The contract can be terminated with one-month notice from either side.
- 12) In case of any complain related to irresponsible behavior of you, the contract will be terminated with immediate effect. The decision of AMC Medical Education Trust regarding continuation/reappointment will be final and you will not be entitled to claim any right for such continuation/ retention / reappointment.
- 13) If you desire to resign prematurely during the service tenure, you may do so by giving one-month notice or salary lieu thereof.

- 14) In case of any intimation to the effect that your service is continued, your service will be automatically stand terminated on completion of the tenure of service of 11 month.
- 15) During the period of your service, you will be entitled for 11 days casual leave (a maximum of 11 days leave within a span of 11 month from the date of employment and not more than 3 days of leave at a one time) and 11 days sick leave proportionate to service rendered by you.
- 16) Women employees can avail maternity leave without pay up to 60 days. Such leave could be available before and/or after delivery of her child.
- 17) In case, you remain absent unauthorized period of more than 5 days constitutionally, your contract will automatically get terminated without any intimation. You will not be entitled for any reappointment (shall become ineligible for further extension) in case his/her service are so terminated.
- 18) You have to enter in legal contract paper with the Medical Superintendent of Respective hospital.
- 19) Your service will be subject to rules and regulation of this institution that are in force and that may be made from time to time.
