 - 11) You have to give Three months' notice Otherwise you have to pay three-month Basic Pay to the AMC MET if you resign after permanent appointment within Bond Period.
 - 12) You have to give One months' notice Otherwise you have to pay one-month Basic Pay to the AMC MET if you resign after completing Bond Period.
 - 13) Rules of Discipline & Behavior are applicable at that time will be in force.
 - 14) New appointed staff may provide Their property declaration of movable & Immovable property in the prescribe format within One month of appointment & When chairman AMC MET order in General or special Order.

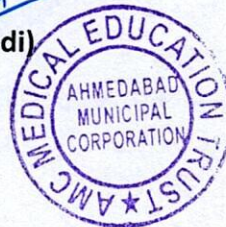
