 - c. Education qualification certificate.



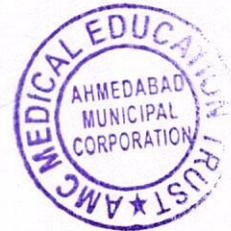
