Condition: -

- 1) If the medical teachers who refuse the promotion after being given the benefit of higher designation, the redesignation has to be withdrawn and a proposal in this regard has to be made to the Chairman / Secretary / Director / Dean.
- 2) This benefit will be available only to those who satisfy all the provisions as per the guidelines of Medical Council of India (MCI)/National Medical Commission (NMC)/Dental Council of India (DCI) in force from time to time and all the conditions as decided by the Government.
- 3) No additional benefit (monetary, Seniority or any other benefit) will be available due to such change in designation.
- 4) sanctioned Scheduled posts of AMC MET owned Medical/Dental Colleges will remain unchanged. Thus, the administrative structure will remain unchanged.
- 5) With this change, the career advancement process and promotion process will remain unchanged. No new post will have to be created for this.
- 6) According to the resolution dated 12/04/2012 of the health and family welfare of GOG., AGP will be available only to 10% of the total posts of professors or to the extent decided by the Government from time to time and that number will remain unchanged. There will be no change due to the proposed change.
