Subject: Appointment Order for the Post of Full time Cardiologist (Non-Teaching) (Cardiology Department) at SVP Hospital-Contractual Period of 11 (Eleven) Months

With reference to your application, you are appointed as Full time Cardiologist (Non-Teaching) in the Department of Cardiology at SVP Hospital under AMC Medical Education Trust, vide Staff Selection Committee Resolution Dt.31/03/2026 & Chairman, AMC MET Resolution No. 37 Dt.11/06/2026 for a contractual period of 11(Eleven) months with a fixed monthly remuneration of Rs.3,00,000/- (Rupees Three Lakhs only), subject to the following terms and conditions:

1. Your appointment is purely contractual for a period of 11(Eleven) months.
2. You will be paid a fixed monthly remuneration of Rs.3,00,000/-
3. You should not have Registration under PMJAY scheme in any other Hospitals.
4. You must attend the hospital on all working days and wear your own apron with name plate affixed.
5. During your employment at AMC MET and thereafter, you shall not disclose any information, whether confidential or otherwise, concerning the affairs of this institution, without prior written approval of the competent authority.
6. You will have to attend routine and emergency work as per the requirement of the institute.
7. You are required to work under the instructions and supervision of your superiors (Medical Superintendent of SVP Hospital), and to co- operate with colleagues in achieving institutional objectives.
8. You will not be entitled to avail benefits available to the staff appointed in regular pay scale and grade process as per the rules and regulations of the institute
9. Bio Metric attendance is compulsory.
10. You are entitled to have one (1) leave per month after arranging routine and emergency duties.
11. Your service will be subject to the rules and regulations of AMC MET in force and as amended from time to time.
12. You have to give one months' notice otherwise you have to pay one-month Basic Pay to the AMC MET if you resign before end of period.
