Sub: - Appointment for the post of Jr. Lecturer on Contract Basis at Nagar School of Optometry.

With the approval of the Chairman, AMC Medical Education Trust Resolution no. 46 dt.17/06/2026, you are appointed on a contractual basis as Jr. Lecturer at Nagar School of Optometry with fix monthly remuneration of Rs.60,000 (Statutory Deduction will be applicable at prevailing rate at the time) on following terms & conditions. for a period of 11 months w.e.f. 01/06/2026 to 30/04/2027 subject to the following terms and conditions.

1. Your appointment is purely on contract basis.
2. You will get remuneration of Rs. 60,000 (Statutory Deduction will be applicable at prevailing rate at the time).
3. You will have to carry out functions of Jr. Lecturer under direct supervision & instruction of Principal- N.S.O. / Secretary- Nagari Eye Research Foundation.
4. During the course of your tenure at N.S.O. or at any time thereafter, you will not disclose to any person/organization/institute any confidential information or otherwise concerning the affairs of this institute.
5. You will be debarred from any type of private practice including private job.
6. You will be required to work strictly in accordance with the instructions of your superior authority. You are expected to co-operate with other employees of the institution so as to achieve all round co-ordinate and efficient performance and making an effective contribution in the development of the institution of excellence.
7. You will not have any type of lien on the scheduled post of Nagar School of Optometry/Ahmedabad Municipal Corporation/Nagari Eye Research Foundation Trust.
8. The contract can be terminated with one-month notice from either side.
9. In case of any complain related to irresponsible behavior of you, the contract will be terminated with immediate effect.
10. The decision of Nagari Eye Research Foundation regarding continuation / reappointment will be final & you will not be entitled to claim any right for such continuation /reappointment,
11. If you desire to resign prematurely during the service tenure, you may do so by giving one month's notice or salary in thereof.
12. You will be entitled for 11 days Casual Leave from the date of your employment and not more than 3 days of leave at a one time. Proportionate to service rendered by you,
13. In case you remain absent unauthorized period of more than 5 days continuously, your contract will automatically terminate without any intimation. You will not be entitled for any re-appointment in case your service is terminated.



14. You have to enter in legal contract paper with Director AMC MET.
15. Your service will be subject to rules & regulations of this institution; that are in force and that may be made from time to time.
16. If your qualification documents are found to be wrong then your appointment will be canceled and further action will be taken.
17. If you desire to resign prematurely during the service tenure, you may do so by giving one-month notice or salary lieu thereof.

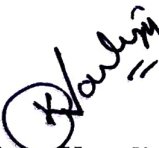
